There are three tiers of ACOSS Membership:

2. Affiliate Membership
3. National Membership

NATIONAL MEMBERSHIP FEES FOR 2011 (fees include GST)

National Membership is available to national organisations with an active interest in promoting social welfare.

In addition to the above ACOSS Membership entitlements, National Members also have voting rights at the Annual General Meeting, including the election of members of the ACOSS Board of Governors.

ACOSS National Membership is based on your organisation's total income each year – 2010-11 membership fee is based on 2009/10 total income. See the table below for the fee payable.

AFFILIATE MEMBERSHIP FEES FOR 2011 (fees include GST)

Affiliate Membership is available to national social welfare organisations that are prevented by their constitution from joining as full members. It is also for government organisations involved in social welfare activities ineligible for or unable to accept member agency status and other organisations with an interest in national social welfare policy.

ACOSS Affiliate members pay a set annual membership fee of \$1,200 (includes GST).
